KGI can issue an I-20 or DS-2019 to students who have confirmed their enrollment and proved their ability to meet the cost of attending KGI. Please note that an I-20 or DS-2019 cannot be issued based on future earnings (i.e. salary statements) or on funds that are not readily available (i.e. documentation of stock holdings or investment portfolios, credit card statements, etc.).
